'Housebuilding 2004' Following the success of last year's conference Bell & Scott have brought together a range of speakers for 2004 to examine some of the pressing issues affecting housebuilders. Speakers will discuss new planning proposals for Scotland, land supply and design. Housebuilding 2004 will feature:

JEREMY ROWAN-ROBINSON – One of Scotland's best known planning experts. In September 2003 he produced the report 'Options for Change' for the Scottish Executive on the possible content of a new Planning Bill for Scotland. He is Emeritus Professor of Law at Aberdeen University and the author of nine books on planning law and related topics. He is a member of the main Board of Scottish Natural Heritage.

PROFESSOR SIR DONALD MACKAY – A noted commentator on economic issues including land supply. Former chairman of Scottish Enterprise and the Malcolm Group, and now chairman of the Scottish Mortgage Investment Trust.

DAVID MACKAY – Partner of MBM Arquitectes, Barcelona. David is probably best known for the urban design of the Olympic Village and Port in Barcelona in 1992. This project showed how a run-down city could become an example of urban regeneration to all of Europe. He was a member of the Senate Advisory Committee for the unification of Berlin, and is now advisor to the Dublin Corporation. In 2002 he was on the panel of judges for the Princes Street Galleries competition in Edinburgh.

BILL DUNSTER – Founder of innovative architecture firm Bill Dunster Architects, he specialises in sustainable developments. He is best known for the BedZed mixed use 'green' housing development with the Peabody Trust in South London. In October 2003 the project won the RIBA Sustainability Award.
